1.0 Introduction

Safaricom PLC is the leading integrated communication services provider in Kenya. The company is continuously expanding the network and upgrading existing capacities to meet the changing needs of its customers. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for supply of various goods and services.

To this end, Safaricom intends to engage services of a reputable supplier for the supply and delivery of a full range of routers and firewalls for MSMEs ranging from high end to medium and low end. Safaricom is therefore soliciting for Expressions of Interest (EOI) from interested qualified suppliers.

2.0 Background

Safaricom has recently rolled out 400G IP core network backbone. 400G is the next generation of network and cloud infrastructure. With a fourfold increase in maximum data transfer speed over 100G, 400G addresses the massive bandwidth demands being placed on network infrastructure providers. Internet bandwidth, Open systems, 5G, FTTH, artificial intelligence (AI), machine learning, IOT and cloud storage all contribute to exponential traffic growth. Consequently, preventing core IP network outage because of new change, Safaricom networking teams must be meticulous when introducing new network nodes (POP), and services. Hence, this necessitates real-time network simulation, modelling, analytics, reporting, performance and forecasting to guide new implementations. Introduction of new service or node will involve simulation prior to, integration to avoid impacting existing service. Providing exceptional customer experiences is not optional, it can mean the difference between loyalty or loss.

3.0 Purpose

This EOI is intended to identify reputable and qualified suppliers who will be able to deliver and integrate routers and Firewalls for MSMES.

4.0 Scope

The scope of the solution will constitute but not limited to:

- a) Supply and deliver routers and Firewalls for MSMES.
- b) Support and maintain the Solution and platform as may be required from time to time.
- c) Provide training on specialized units to the Operations and Planning teams.

The full details of the scope will be provided in an RFP (Request for Proposal) that will be sent out to the successful suppliers shortlisted through this EOI process.

- Any costs associated with the preparation and submission of the response to the EOI shall be borne by the vendor.
- State if you intend to submit this bid as a joint venture/consortium or any other joint format.
- Safaricom and its authorized representatives are hereby authorized to conduct any inquiries or investigations to verify the documents and information submitted in connection with this application.
- Only the suppliers who meet our minimum requirements will be considered for further discussions.

7.0 Next Steps

Organizations that express interest to participate in the provision of the above-mentioned service, and meet our requirements, shall be prequalified for the provision of this service in their area(s) of expertise, and invited to the tender subject to them providing required documentation and demonstrated ability to deliver the requirement.

Only those institutions that meet the minimum evaluation and pre-qualification criteria will be considered for further discussion on the tender process. The formal next process will be as below:

- Review of submitted Expressions of Interest (EOI)
- Prequalification of the shortlisted suppliers who are not currently in our supplier database.
- Issuing of tender to prequalified suppliers
