With a fourfold increase in maximum data transfer speed over 100G, 400G addresses the massive bandwidth demands being placed on network infrastructure providers. Internet bandwidth, Open systems, 5G, FTTH, artificial intelligence (AI), machine learning, IOT and cloud storage all contribute to exponential traffic growth. Consequently, preventing core IP network outage as a result of new change, Safaricom networking teams must be meticulous when introducing new network nodes (POP), and services. Hence, this necessitates real-time network simulation, modelling, analytics, reporting, performance and forecasting to guide new implementations. Introduction of new service or node will involve simulation prior to, integration to avoid impacting existing service.
