#### 1.1. Introduction

Safaricom is the leading integrated communication services provider in Kenya and has a steadily growing subscriber base of mobile and enterprise clients. The company is continuously expanding and upgrading its systems and processes to meet the changing needs of its customers. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for the supply of various goods and services.

To this end, Safaricom intends to engage services of a reputable company to provide Data Centre & Main Switch Rooms (MSRs) cable installation and upgrade services. Safaricom is therefore soliciting for Expressions of Interest (EOIs) from interested qualified companies.

#### 1.2. Background and EOI Requirements

Safaricom has various Main Switching Rooms (MSRs), Media Gateways (MGWs) and a Data Centre spread all over Kenya. These sites' cable infrastructure requires to be continuously upgraded as new services are provisioned and/or as changes are made to enhance service provision. The process is expected to continuously optimise space, improve reliability and cable manageability in these sites as services are expanded or decommissioned.

Safaricom is seeking to engage a company that has capabilities to supply, install and commission this cable infrastructure and one that has capabilities in services migration on a fixed term contract.

#### SCOPE:

- 1. Supply, installation, and commissioning of Data Center cabling infrastructure,
- 2. Migration of existing services to the newly installed infrastructure,
- 3. Recovery of replaced infrastructure.

This EOI's aim is to identify suitable suppliers that can demonstrate sufficient capability to provide these services in a way that meets Safaricom's requirements. After capable suppliers have been identified in this EOI, a Request for Proposals will be issued, and a supplier competitively identified.

Safaricom is therefore soliciting for Expressions of Interest from interested companies clearly showing the following:

- Years of experience as a provider of similar services.
- The supplier's principal place of business.
- Three years audited accounts.



- Certification required to offer these services. These should include necessary statutory, company and staff certifications.
- List of projects and clients where the services have been offered in the last 5 years with reference contact details in the provided format below.
- Any other information to support your experience in this scope.

#### 1.3. Submission of Responses

**NB:** Response attachments to be shared via Microsoft OneDrive and **NOT** GoogleDrive or WeTransfer or Dropbox. Submissions sent via GoogleDrive or WeTransfer or Dropbox will automatically be disqualified.

- Prequalification of shortlisted suppliers.
- Issuing of tender to prequalified suppliers.
- Award to successful bidders.
