6	List of past power line construction projects (not more than 5 years) with Kenya Power or Rural Electrification Authority or any other works of similar nature, if any	
7	Any additional information that Safaricom should be aware of.

- 2. Have all the attachments supporting your submission in a separate zipped file/s. If your submission is above 20MB, share the files through Microsoft OneDrive (it's free up to 5GB). Ensure you provide access to the email PGathura@safaricom.co.ke after creating the link.

The attachments should be submitted in folders properly labelled as per the index listed above. You will have folders 1 to 7 as listed above. Ensure you properly label the attachments and have them referred to in the excel containing the response. **DO NOT APPEND ATTACHMENTS IN THE EXCEL.**

The submission format will be an email with the excel attached and a Microsoft OneDrive link with the supporting attachments.

NB: Response attachments to be shared via Microsoft OneDrive and **NOT** GoogleDrive or WeTransfer or Dropbox. Submissions sent via GoogleDrive, or WeTransfer or Dropbox will automatically be disqualified.

- Review of submitted Expressions of Interest.
- Pregualification of shortlisted suppliers.
- Issuing of tender to pregualified suppliers.
- Award to successful bidders.
