#### 2. AIMS AND OBJECTIVES

Safaricom Limited operates a fleet of 473 vehicles scattered across the country. The fleet is managed centrally by the Fleet and Travel team. This Expression of Interest (EOI) document is intended to lead to the identification of suppliers that can demonstrable having sufficient capacity to provide these services in the best possible way and in a manner that enables Safaricom to meets its expectations.

Safaricom is therefore soliciting from interested companies an Expression of Interest clearly showing the following:

- Tyre labs Locations countrywide.
- Partnerships with tyre disposal companies
- Authority from manufactures and relevant authorities to offer such services (Provide evidence of compliance with statutory requirements, certification and all other relevant licenses).
- CV's of key staff that are directly contracted by the company to inspect vehicles and fit in the tyres, batteries and shocks
- Current list of clients where similar services are provided.
- Years of experience as prime service providers
- Company Health and Safety policy, processes and procedures

## 3. SCOPE OF SERVICE

- The supplier will be expected to carry out the following pit stop services, but not limited to;
  - Compressive vehicle Inspection and reporting.
  - Tyre fitting and tyre rotation
  - Tyre digital wheel alignment, wheel Balancing, caster camber balancing
  - Tyre pressure Adjustment to the recommended PSI
  - Assess the condition of battery and replace where necessary.
  - Assess the condition of the suspension including shocks and replace where necessary.
  - Tyre repair puncture as a value add.

It is the responsibility of the contractor to show commitment to providing consistent high quality services throughout its countrywide locations.

The supplier must ensure;

- After delivery service Ensure tenacious follow-ups of staff concerns.
