Safaricom PLC is the leading integrated communication services provider in Kenya. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for supply of various goods and services.

To this end, Safaricom intends to engage reputable suppliers for the supply of cooling solutions for BTS, facilities and data centers. Safaricom is therefore soliciting for Expressions of Interest (EOI) from interested qualified supplier.

2.0 Scope

Suppliers are required to provide cooling solutions consisting of an indoor unit and an outdoor unit in the following systems:

- Precision air conditioning: perimeter cooling and In-row cooling units.
- Comfort cooling air conditioners and AC/DC air conditioners.
- Thermal Containment Solutions
- Chillers Systems
- Indirect Evaporative Units
- Liquid Cooling
