#### INTRODUCTION

#### BACKBROUND

Safaricom operates two fully fitted Gym facilities complete with steam and sauna at Safaricom' Jambo Contact Centre (Mombasa Rd) and Safaricom Head Quarters (Waiyaki way. We are therefore seeking to identify suitable vendors with the relevant capacity to meet current Safaricom need for supply of commercial gym equipment at our Jambo Contact Centre branch on a four year lease basis.

- The principal place of business and warehouse facilities
- CV's of key staff that are directly contracted by the company on a technical capacity to maintain gym equipment.
- Current list of clients where similar services (lease of gym equipment) are provided including the size of the gym facilities and list of commercial gym equipment supplied.
- List of commercial gym equipment available under the lease option including brands
- Dealership rights for the gym equipment
- Company Health and Safety policy, processes and procedures
- Company employment policy, processes and procedures clearly listing the induction process and training programmes.
- Spare parts ordering procedure and timelines

# SCOPE OF SERVICES

The general scope for provision of gym equipment lease at Jambo Call Centre shall include but shall not be limited to:

- Supply and installation of commercial equipment i.e Cardio Equipment Strength equipment, Benches and Racks ,Free weights, Spin bikes ,Massage bed,Massage seats e.t.c
- Preventative Maintenance and ad hoc repairs
- Supply of spare parts
