#### 1.1. Introduction

Safaricom is the leading integrated communication services provider in Kenya and has a steadily growing subscriber base and enterprise clients. The company is continuously expanding and upgrading its systems and processes to meet the changing needs of its customers. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for supply of various goods and services.

To this end, Safaricom intends to engage services of a reputable supplier to **Supply Towers** for its network rollout activities. The intention is to engage the supplier in the supply and temporary storage of new towers for GSM and enterprise sites. Safaricom is therefore soliciting for Expressions of Interest (EOI) from interested qualified suppliers.

#### 1.2. Background and EOI Requirements

Safaricom has continuously rolled out Base Transceiver Stations and client enterprise sites across Kenya and intends to continue rolling out these sites as it deepens its network coverage. One of the key components of these sites is the tower.

This EOI intends to identify competent suppliers that can demonstrate sufficient capacity to supply these towers in a manner that enables Safaricom meet its expectations. The identified suppliers will be invited for a competitive tendering process from which the supplier/s to be engaged will be identified.

Safaricom is therefore soliciting for Expressions of Interest from interested companies clearly showing the following:

- Years of experience as a supplier of towers.
- The principal place of business
- Countries where the company supplies the towers
- List of clients where the towers have been supplied in the past five years with reference contact details. Also include current clients, where applicable.
- Three years audited accounts.
- Any additional information that supports your capabilities in this scope.
