## 1. Introduction and Background

Safaricom PLC is the leading integrated communication services provider in Kenya. The company is continuously expanding the network and upgrading existing capacities to meet the changing needs of its customers. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for supply of various goods and services.

To this end, Safaricom intends to engage services of a reputable supplier for the supply of Diesel Generators for BTS, facilities and data centers. Safaricom is therefore soliciting for Expressions of Interest (EOI) from interested qualified suppliers.

## 2. Purpose

This EOI is intended to identify reputable and qualified suppliers who will be able to deliver on the scope (but is not limited to) below:

1. Supply of diesel generators of various sizes and capacities.
2. Commissioning generators from time to time as may be required.
3. Support the newly installed units and existing units as may be required.
4. Provide training on specialized units to maintenance teams.
5. Provide second level support.
6. Provide ready stock of consumables/spare parts.

The generating set will constitute but not limited to the Engine, the Alternator, appropriate sound attenuated enclosure, Fuel tank controls.

The full details of the scope of the generators will be provided in an RFP (Request for Proposal) that will be sent out to bidders shortlisted through this EOI process.

## 3. EOI Response requirements

Interested prospective suppliers are requested to submit the following documents as part of their response to this Expression of Interest (EOI):

7	List of past projects (not more than 5 years) and ongoing projects of similar scope delivered to a telecommunication company or any other works of similar nature to corporate clients. Demonstrate your industry experience as a supplier of generators.		
8	Verifiable References from beneficiaries of similar scope or currently in operation/contract. Specific details including capacities of the deployed solutions should be provided.		
9	Details of the company's key staff and their technical qualifications.		
10	A basic technical proposal to satisfy the requirements by Safaricom to the extent detailed in this EOI document under Section 4 below.		
11	Scope of work currently being provided to Safaricom, if any. Also, indicate if you have a working relationship with Vodafone Group.		
12	Share name, contact details and position of the person primarily responsible for this EOI.		
13	Any additional information that supports your capabilities in this scope including any joint ventures you may have for this type of projects or any additional information that Safaricom should be aware of.		

#### 4. Technical Requirements

Interested suppliers should attach a separate Excel document with specific responses to each of the Technical requirements below as minimum:

- a) Range of generator sets – minimum and maximum ratings in standby, prime and continuous ratings.
- b) Type of Engine.
- c) Type of Alternator.
- d) Supervision Monitoring, licenses requirement and control both at local and remote level
- e) Canopy of the sets
- f) Electrical Systems – startup, battery charging, AVR
- g) Diesel Fuel System – belly tanks, fuel separators, fuel feed system, fuel alarms,
- h) Overall dimensions, exhaust, sound pressure, fuel consumption.
- i) Energy efficiency technologies/integration opportunities.

#### 5. Submission of Responses

- The receipt of a response shall not bind Safaricom into any contractual agreements with the bidder. Any costs associated with the preparation and submission of the response to the EOI shall be borne by the vendor.
