



TERMS AND CONDITIONS FOR RETAIL DEVICE OFFER

“JISORT NA BONGA”

The following terms and conditions apply to the Safaricom Retail Device Offer (“the Offer”):-

1. Eligibility

- a) This Offer is open to all customers who purchase the Participating Devices from any recognised Safaricom Retail Shop. To get the Free Resources, must be a Safaricom subscriber.
- b) The Participating Devices are in clause 5 below and will also be published in the media, Safaricom Shops and Safaricom Website (www.safaricom.co.ke).
- c) Safaricom Retail Shops are published on the Safaricom website.

2. Offer period

- a) The Offer runs from **00:00hrs 28th May, 2015** to **23:59 hrs on 2nd June, 2015**.

3. The Offer

- f) Devices are sold to you **subject** to the Manufacturer’s limited warranty.

- b) Send the device IMEI to short code 440 for activation of the Free Data Bundle and Free airtime or through accessing the data bundle portal at www.safaricom.co.ke/bundles.
- c) An SMS confirming that the Free Resources have been successfully activated will be sent to you from short code 440.
- d) Once you use all your Free Resources you will be charged the applicable published Safaricom rates for continued usage.
- e) Corporate customers can also participate in the Offer by allowing their employees to redeem their Bonga Points as provided for in the Corporate Bonga Redemption program.
