1.1. Introduction

Safaricom is the leading integrated communication services provider in Kenya and has a steadily growing subscriber base of subscribers and enterprise clients. The company is continuously expanding and upgrading its systems and processes to meet the changing needs of its customers. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for supply of various goods and services.

To this end, Safaricom intends to engage services of reputable suppliers for the supply of **Power Tools/Kits** for use by its engineers. The intention is to engage the suppliers in the supply and support of these tools. Safaricom is therefore soliciting for Expressions of Interest (EOI) from interested qualified suppliers.

1.2. Background and EOI Requirements

Safaricom has continuously rolled out telecommunication services across Kenya and intends to continue rolling out these services as it deepens its coverage. This has necessitated continuous need for:

- a. Troubleshooting and fault detection
- b. Fault Rectification, Maintenance and Repairs
- c. Taking Measurements and Sampling of Measurements
- d. Performance Monitoring
- e. Network, System or Network Element Configuration
- f. Testing and Commission

The scope of supply will be power tools/kits.

This EOI is intended to lead to the identification of suppliers that can demonstrate having sufficient capability to provide these tools in the best possible way and in a manner that enables Safaricom meet its expectations. The identified suppliers will be invited for a competitive tendering process from which the suppliers to be engaged will be identified.

Safaricom is therefore soliciting for Expressions of Interest from interested companies clearly showing the following:

- Years of experience as a provider of these tools
- The principal place of business.
- Countries where the company provides the power tools/kits.
- List of OEMs your company represents with supporting Manufacturer Authorization Letters
- Three years audited accounts.
- Any additional information that supports your capabilities in this scope.
