#### 1.1. Introduction

Safaricom is the leading integrated communication services provider in Kenya and has a steadily growing subscriber base of subscribers and enterprise clients. The company is continuously expanding and upgrading its systems and processes to meet the changing needs of its customers. To meet this objective Safaricom continuously seeks to partner with competent suppliers and service providers for supply of various goods and services.

To this end, Safaricom intends to engage services of reputable suppliers for the provision of **Spare Parts Management Services (SPMS)** for its network. Safaricom is therefore soliciting for Expressions of Interest (EOI) from interested qualified providers.

We had issued this same document in December 2019. If you had responded to that request, you don't need to respond again.

#### 1.2. Background and EOI Requirements

Safaricom is keen on effective, efficient and cost-effective Spares Part Management and Logistics Services in reference to the replacement of Active and Passive spares parts recovered from the network by Safaricom Technical Staff or Safaricom Appointed Agents as faulty and the subsequent facilitation of working replacement spares, either repaired and tested or new. To achieve this, Safaricom relies on contracted service providers who are engaged on a fixed term contract.

The scope of the service offering is:

- 1. Spares Dimensioning and Order Processing.
- 2. Warehousing and Distribution (Logistics)
- 3. Testing, Repair and Return.
- 4. Warranty Administration.
- 5. Stock Control and Accounting.
- 6. Master Data Maintenance.
- 7. Reporting.

This EOI is intended to lead to the identification of suppliers that can demonstrate having sufficient capability to provide these services in the best possible way and in a manner that enables Safaricom meet its expectations. The identified suppliers will be invited for a competitive tendering process from which the suppliers to be engaged will be identified.

Safaricom is therefore soliciting for Expressions of Interest from interested companies clearly showing the following:

- Years of experience as a provider of these services.
- The principal place of business.
- Countries where the company provides the services.



- List of clients where the services has been offered in the past five years with reference contact details. This should include the scope of service offering and client/customer.
- Three years audited financial statements.
- Details of Kenyan presence or partnerships and plans of setting up in Kenya.
- Any additional information that supports your capabilities in this scope.
