1.0 Introduction

Safaricom has enjoyed rapid growth since her inception largely driven by the innovation and delivery of new and sophisticated services riding on telephony and data services. In line with the strategy to provide innovative home solutions, Safaricom launched the BIGbox in August 2015 offering free-to-air TV content and 4G enabled Internet connectivity. Based on changing market trends, customer feedback and lessons learnt with BIGbox 1.0, the home solutions team developed a BIGbox Version 2.0 dubbed Safaricom GIGA box and launched this in November 2017.

The GIGA box has been instrumental in driving up renewal rates among Fibre customers. Fibre customers who buy the GIGA box have a higher than average renewal rate. This Box also offers our customers in non-Fibre ready areas, the easiest way to set up a home Wi-Fi.

Due these user expectations, Safaricom is planning to expand its Set Top Box range, to ensure that more Fiber users have access to great content.

A set-top box that runs on the latest Android TV OS version.

2.0 Instructions to Respondents

- i. Analyze the contents in the section titled 'Introduction' and 'scope'
- ii. Build a detailed response showcasing what product solution you would propose to meet the business goal
- iii. Provide a comprehensive write up on your industry experience.
- iv. Detail all other products that your organization deals with related to the requirements captured in the business goal
- v. Outline the industry best practices and trends for Safaricom considerations.
- vi. Provide the following details for Safaricom to review:
 - a. A functional description of the product(s).
 - b. A technical description of the product(s).
 - c. All relevant product data sheets
 - d. A signed letter of introduction and overview of your company
- vii. The EOI response must **not** include any pricing/commercial proposal.
- viii. All responses should be provided in standard file formats i.e. PPTs, .XLSs, .DOC(X), PDF.
- ix. All responses should be provided in electronic format only i.e. emailed to RAMAYO@Safaricom.co.ke
- x. All technical questions related to this RFI should be sent to Nodiwourl@safaricom.co.ke
- xi. The receipt of a response shall not bind Safaricom into any contractual agreements with the bidder. Such arrangements shall only come into place once a tender process has been undertaken and an award issued to successful bidder(s) as evaluated technically and commercially.
- xii. Any costs associated with the preparation and submission of the response to the EOI shall be borne by the vendor.

3.0 Scope

The supplier will be required to:

- 1. Provide an Android STB that meets the stated requirements under a Vendor Managed Inventory (VMI) supply model.
- Avail 2% SWAP stock units for each purchase order in case of faulty Units

- 3. Provide After Sales Support directly or through an appointed partner.
- 4. Provide at least 1 Year warranty to cover Manufacturer's defects
- 5. Where needed, provide basic training needed to effectively sell the device to end users.
- 6. Provide sample STB for testing purposes at no cost to Safaricom (one sample is enough).

4.0 Aims and Objectives

The main objective of the EOI are to:

- 1. Identify partners that can supply the devices above under a Vendor Managed Inventory supply model.
- 2. Pre-qualify and float a tender to potential providers following this EOI evaluation
- 3. Agree on a framework of engagement with successful partners

This document is soliciting interested OEM and/or OEM partners to participate in this exercise. The participating entity must be duly registered and reputable firm(s) with the capacity to provide or demonstrate that they have a mature product that can be used for the purposes mentioned above.

5.0 EOI Content

The EOI proposal/response should contain the following information:

- Legal Certification & Registration by relevant regulatory authorities i.e. Certificate of incorporation, Single Business Permit, Tax Compliance Certificate, Memorandum and Articles of Association for the Company, VAT Certificate Of Registration, Official search report Form CR12, Form of Annual Return of A Company Having a Share Capital, Registration by relevant body/institution as an approved training institution, Registration by the National Industrial Training Authority, Certificate of Cover for Professional Indemnity.
- Company organogram and CVs of resource persons including copies of educational
 qualifications, certificates of registration by relevant authorities and competency to
 offer QA trainings (stating areas of expertise). Note emphasis will be placed on the
 calibre of trainers provided.
- Demonstrate capacity to undertake the above listed services detailed scope and methodology of the trainings offered, sample training manual, sample course outline

- and course content, sample timetable to be used in training for each of the trainings the vendor is able to provide.
- Provision of recent client referrals/ referral letters where similar services have been carried out and number of staff trained providing contact address, scope of works and duration.
- Details of the Bidder's physical premises and contact details.

6.0 Next Steps

- Institutions that express interest to participate in the provision of the abovementioned service, and meet our requirements, shall be prequalified for the provision of this service in their area(s) of expertise, subject to the provision of required documentation and demonstrated ability to deliver the trainings.
- Only those institutions that meet the minimum evaluation and pre-qualification criteria will be considered for further discussion on the tender process.
