- 4.4 The EOI response must not include any pricing/commercial proposal.
- 4.5 All responses should be provided in standard file formats i.e. XLSs, DOC(X) and PDF.
- 4.6 The receipt of a response shall not bind Safaricom into any contractual agreements with the bidder. Such arrangements shall only come into place once a tender process has been undertaken and an award issued to successful bidder(s) as evaluated technically and commercially.
- 4.7 Any costs associated with the preparation and submission of the response to the EOI shall be borne by the vendor.
- 4.8 State if you intend to submit this bid as a joint venture/consortium or any other joint format
- 4.9 Experience and staff information to be submitted in the format provided in appendix 1 (Information on staff and organization experience)
