1. INTRODUCTION

2. OBJECTIVES

This Expression of Interest (EOI) document is intended to lead to the identification of suppliers that can demonstrable having sufficient capacity and experience to Extension Services for *DigiFarm* in the best possible way and in a manner that enables *DigiFarm* to meets its expectations.

Safaricom is therefore soliciting from interested companies an Expression of Interest clearly showing the following:

- A company profle detailing the years of experience in the Provision Extension and Related Services
- Authority from relevant authorities to offer Extension (Provide evidence of compliance with statutory requirements, certification and all other relevant licenses).
- Current list of clients where similar services have been carried out
- Geographical presence i.e. the regions that the vendor has offices

3. <u>SCOPE OF SERVICES</u>

The nominated supplier will be required to provide the following scopes services of services among others;

- Farmer Needs Assessment-Help to understand farmers' constraints and management practices, and to identify the inputs, and Key Extension messages they need for increasing their crop productivity.
- Woking with Extension Agents and DBAs work to advise on modification of their existing practices.
- Designing of Tools for Extension Agents and DBAs to assist communication of key Extension messages to farmers.
- Identification and training of self-employed Village-based "Agri-preneurs" or "Advisors"-DigiFarm Village Based Advisors (DBAs) who are linked to DigiFarm Depots to promote right input together with good agricultural practices, and who provide linkages to buyers of farmers' produce.
- Repprting as may be agreed from time to time
